

The Violet H. Simmons Scholarship Fund Summer Enrichment Scholarship Application Guidelines

The Violet H. Simmons Scholarship Fund Summer Enrichment Scholarship (SES) seeks to support college students who are graduates of Webutuck Central School and who demonstrate academic achievement, potential for intellectual growth and commitment to community involvement.

We wish to make it possible for students to undertake an educational experience of personal and intellectual growth that will enable them to cultivate a sense of curiosity about the world and enhance their ability to serve others in a leadership capacity.

Webutuck graduates who are enrolled in college will be able to take advantage of an unusual learning opportunity - one which may not otherwise be possible for the student - by underwriting the cost of that educational experience to an amount up to \$5,000.

Without intending to limit the choice or creativity of scholarship applicants, the following are suggested ideas around which an applicant might construct a scholarship application:

1. Involvement in a service project of a local, national or international nature.
2. Travel in conjunction with a particular area of study.

3. Internship in a field of interest in the private, public or nonprofit sector for which the pay would be insufficient without the scholarship.
4. Independent Study project that could not be pursued without the scholarship.

Areas of study, work or service may include but are not limited to the arts, government, ecology, history, literature, the sciences, children or youth.

Eligibility

Applications are accepted from students who have graduated from Webutuck Central School and who will be enrolled in their second or third year at an accredited college or who will be enrolled in the second year of a two year accredited college course for the school year 2006/2007. (Students who are enrolled in a two-year course and are planning to transfer to a four-year school should wait to apply until their second or third year.) A student need not have applied for the Violet H. Simmons Scholarship while a senior at Webutuck in order to be eligible to apply. Programs are not required to take place during summer if the student's college operates on a trimester schedule.

Applications are accepted for projects that provide college credit if the applicant can demonstrate that the proposed project will provide him or her with an extraordinarily enriching experience, above and beyond his or her traditional study program.

Awards

Awards depend on the amount available from the fund and may range up to \$5,000. Awards may be deferred for up to twelve months but the funded projects must have taken place by the time the applicant begins his or her final year of college. Undergraduates will have

two opportunities to apply but, if funded once, may not reapply.

Deadline

Completed applications must be postmarked on or before **November 15th, 2006**.

To Apply

Complete the attached application form and send it to the above address along with:

- An essay on what your own goals are in relation to your proposal and how your request meets the vision of the Violet H. Simmons Scholarship Fund Summer Enrichment Scholarships.
- A copy of your college transcript including grades from the most recently completed semester.
- Two letters of recommendation from a recent teacher, counselor, community leader or employer.

Review Process

Applications will be reviewed by the Board of Trustees of the Violet H. Simmons Scholarship Fund. The Board will interview finalists in December or January.

Review Criteria

The Board will review requests for scholarships according to the following criteria:

- The potential impact of the educational experience on the applicant

- The potential for the project to develop the applicant's intellectual curiosity
- The potential for the project to develop the applicant's leadership potential
- The potential for the project to provide or lead to community or humanitarian service, not necessarily in the Webutuck school community.
- Applicant's demonstration of ability to fulfill the project as planned.

Notification

Applicants will be informed of the Foundation's decision by January 31st.

Reporting Requirements

Recipients of Summer Enrichment Scholarships will be required to meet with the Simmons Scholarship Board of Trustees upon completion of their projects to report on how their educational experience has helped them meet their goals as expressed in their application.

Applicants are encouraged to consider this as a starting point in research on summer programs. Your college may also have information on these and other programs.

Examples of eligible projects:

- Internship at a company or organization that will enable you to focus on a particular area of study. In this case the SES could provide payment (through the organization) to you so that you would be able to do this work and earn income.
- Work or study at a nonprofit organization, local or otherwise, that will contribute to the community.
- A study program either in the U.S. or abroad either through an organization or a self-designed project that will develop your intellectual curiosity and leadership skills.

All Global Routes programs follow the same basic model:
Orientation : While exploring the environment, culture and history of their host country, students participate in a variety of activities in preparation for their upcoming village experience.
Homestay/Service Project : While living as a member of a family and immersing themselves in the everyday life of the village, students work on primary and secondary service projects alongside community members. Typically, high school projects are construction-based, while the primary work of college volunteers is teaching in local schools.
Final Travel : While reflecting on the program's experiences and how they will integrate it into their life back home, students embark on a journey throughout the region's rich natural and cultural landscapes.

Dear Student

What are you doing next summer? It's not too early to think about it. Is there something you'd really like to do but aren't sure you can afford to? We'd like to help you do something that will introduce you to new people and ideas, or enable you to provide a service to an organization in your community, or let you explore something you've always wondered about but never had the time. This is the point in your life to take that chance....reach for that star.....have fun and....grow.

We encourage you to see if your college has an office that helps students with their summer plans. If so, go see them. Tell them about this program and ask them for help and ideas about how to effectively apply for it.

The trustees of the Violet H. Simmons Scholarship Fund are willing to meet with you in August to discuss your ideas and to advise you on how to turn your ideas into a plan of action. The trustees' contact information is attached.

The application and supporting information are enclosed. If you are enrolled in a two-year course, you are eligible to apply now for the summer of 2007, i.e. the summer between your first and second years. However, if you are planning to transfer to a four-year school, please wait to apply until next year or the following year. We advise this because you will be competing against students in a four-year program who, being older and having had more time in school, may be better able to define an enrichment experience that would make a significant impact on themselves and their career. But if your studies will be completed in two years and you have a strong desire and motivation to undertake an enrichment experience, please do apply.
