This has a dramatic Impact on the Tax
Rate of ALL taxpayers in the WCSD
At this time the average school tax rate
would drop from \$12.43 per \$1,000 to
\$10.38 per \$1,000

What Does This Mean for My Tax Rate:

Year	Scenario	Levy	Levy %	Tax Rate per \$1,000
18/19	Current	\$13,893,572		\$12.43
19/20	Proposed Levy	\$14,718,850	5.94%	\$10.38**

Formula Used to Estimate Tax Impact for Homeowners

Home's Assessed Value	Current 2018-2019 Tax Rate	2019-2020 Tax Rate (Based on Tentative Taxable Values 5/1/19)	Decrease Rate	Estimated Annual Tax Decrease
\$100,000	\$12.43	\$10.38	(\$2.05)	(\$205)
\$200,000	\$12.43	\$10.38	(\$2.05)	(\$410)
\$300,000	\$12.43	\$10.38	(\$2.05)	(\$615)

Disclaimer: Final tax rates vary by town and are contingent on taxable assessed values and NYS equalization rates. Above estimates are based on 5/1/19 property assessments and assume 2018-2019 equalization rates – actual data will be available in August 2019.

Formula to Calculate Estimated School Tax

The Assessed Value of Your home divided by \$1,000 multiplied by the taxable rate equals the taxes you will pay on average for the year.

Example:

In 2018-2019 a home assessed at \$250,000 most likely was paying the following school taxes:

Assessed Value of \$250,000/\$1,000 = \$250 x \$12.43 = \$3,107

In 2019-2020, the same home with an Assessed Value = \$250,000/\$1,000 = \$250 x \$10.38 = \$2,595

So, this example would show a **SAVINGS of \$512** in Taxes

This is a model that can be used to ESTIMATE. This is based upon information provided by the County as of 5/1/19

Basic STAR & Enhanced STAR

All qualified and eligible Basic & Enhanced STAR recipients will continue to receive their Exemptions!

The Property Tax Relief Credit will not apply though due to the fact that the District is above the Levy Limit.

What Happens if the Budget does not Pass by a 60% +1 Super Majority

- BOE would have the option to put a 2nd Vote Out that is the Same, Less or More than 1st - Vote would take place on Tuesday, June 18, 2019
- BOE could decide to go to Contingency Budget

What Happens if a 2nd Budget does not Pass?

- BOE would have to adopt a Contingency Budget

Items to be Considered in a Reduction of a Contingency Budget?

Further Reduction of \$825,277 to be at a 0% Tax Levy Increase

- Music Teacher 1.0 FTE (0.5 new & 0.5 existing)
- Art Teacher 0.6 FTE (0.4 already reduced)
- Physical Education Teacher 0.5 FTE
- Math Teacher 1.0 FTE
- Social Studies Teacher 1.0 FTE
- Elementary Teachers K-6 5.0 FTE
- Field Trips
- JV Sports
- Additional Athletic Funding
- Instructional Leads
